#### **Learning Resources Center**

The construction permits for the LRC will be released in two parts by the Division of the State Architect. Increment 1 is expected to be approved by January 2023. In anticipation of this, the team has been planning for startup of construction activities for this phase. This portion of the project primarily involves site work which includes: grading, shoring, soil mixing, and ground improvements. Although visibility from the street will be limited, it is a critical initial step in the construction process. Increment 1 is expected to start in March 2023 and completed by July 2023. We understand there will be impacts to our college community and our neighbors and we will be doing our best to strategically mitigate the impacts. On November 29, the team held a town hall meeting where we presented an update to the design and schedule and also discussed site logistics along with potential impacts and mitigation measures the District will be implementing. ## **Maintenance & Operations**



College of Marin Gardening staff have been working with Instructor Fernando Agudelo-Silva and his students by preparing a portion of a planting bed north of the Student Services building that needed revitalization. The garden's primary purpose is to provide plants used by Monarch Butterflies for food and habitat. About 20 feet in diameter, the garden was planted with 80 dormant narrow Milkweed Plugs, 45 perennials and 16 red fescue plants.

Milkweed is the sole host plant of the monarch butterfly. Monarchs lay eggs specifically on milkweed, the eggs hatch into caterpillars and the caterpillars eat the foliage. The leaves contain cardiac glycosides, compounds that affect heart function, making them toxic to most species of birds and mammals. By ingesting the leaves, monarch larvae become toxic and predators avoid them. The other plantings, including flowers and native plants, are meant to attract and be beneficial to other pollinating insects as well as to provide visual interest.
