

Measure B Projects



The new Learning Resource Center is almost completely through the Design Development phase. Final engagement meetings with faculty, staff, and key community partners will occur over the next few weeks. The next and final phase of design, Construction Documents, will begin early December and conclude in spring 2022.

Design Development has been completed and the documents are being reviewed by staff for the Bolinas Field Lab. Input from faculty, staff, and the community has been incorporated into the current design.

Construction on 830 College Avenue continues to move along. Installation of windows and doors has been completed and final touch up painting is in progress. Furniture procurement is being finalized

Miwok Aquatics and Fitness Center is drawing to a close. Punchlist completion is in progress and County health department approval and DSA approval for occupancy of the main building, warm—up pool and competition pool has been secured. The facility will begin to hold classes November 8th. The Dive Center construction is ongoing as the construction of the hydrotherapy spa continues and is slated to open by February 1, 2022.

Fiscal Services Reminders

Insurance Requirements for Consultants

Please ensure all required certificates of insurance are endorsed to the District and are attached to the District Agreement for Services (AFS) before the hiring department signs.

Insurance requirements are listed on the AFS as follows:

- Workers Compensation (9a) is required if the consultant has employees but is not required if the consultant does not have employees
- Commercial or Comprehensive General Liability (9b) is always required
- Automobile Liability (9c) is required of anyone who drives a vehicle on campus
- General Liability and Automobile Liability (9d) should include the endorsements listed in numbers 1-4
- Professional liability (9e) is required if the consultant could say or do something that could cause harm (in general "harm" is monetary such as financial loss).
