- community and cultural enrichment

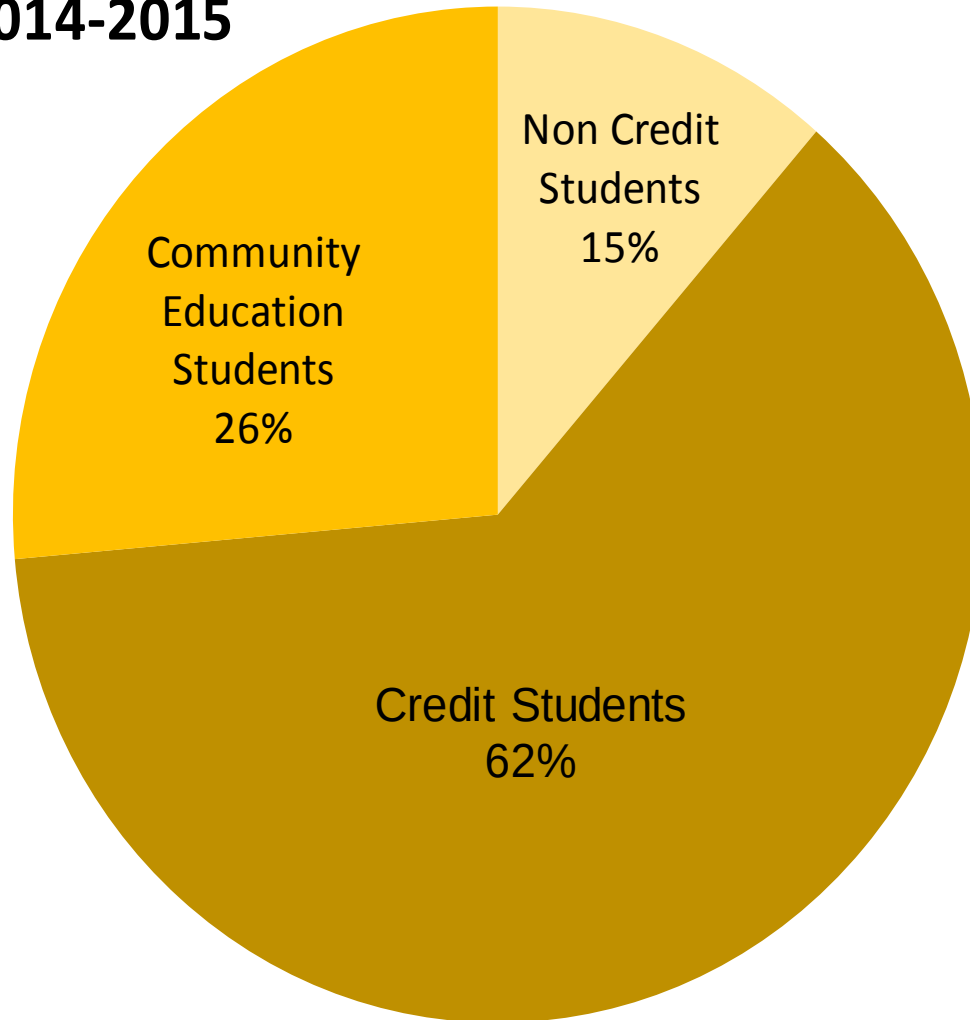
College of Marin responds to community needs by offering student-centered programs and services in a supportive, innovative learning environment that promotes social and environmental responsibility.

Student Enrollment

- 62% enroll in credit courses
- 15% enroll in noncredit classes including English as a Second Language
- 26% enroll in community education courses
- Approximately 80% enroll at the Kentfield Campus and 20% enroll at the Indian Valley Campus
- 22% of all Marin County high school graduates enroll directly at College of Marin after graduation

Comprehensive Offerings

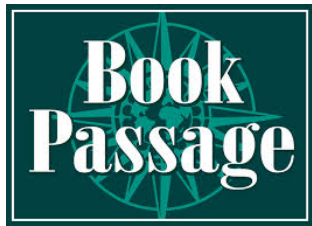
- 60 different associate degrees

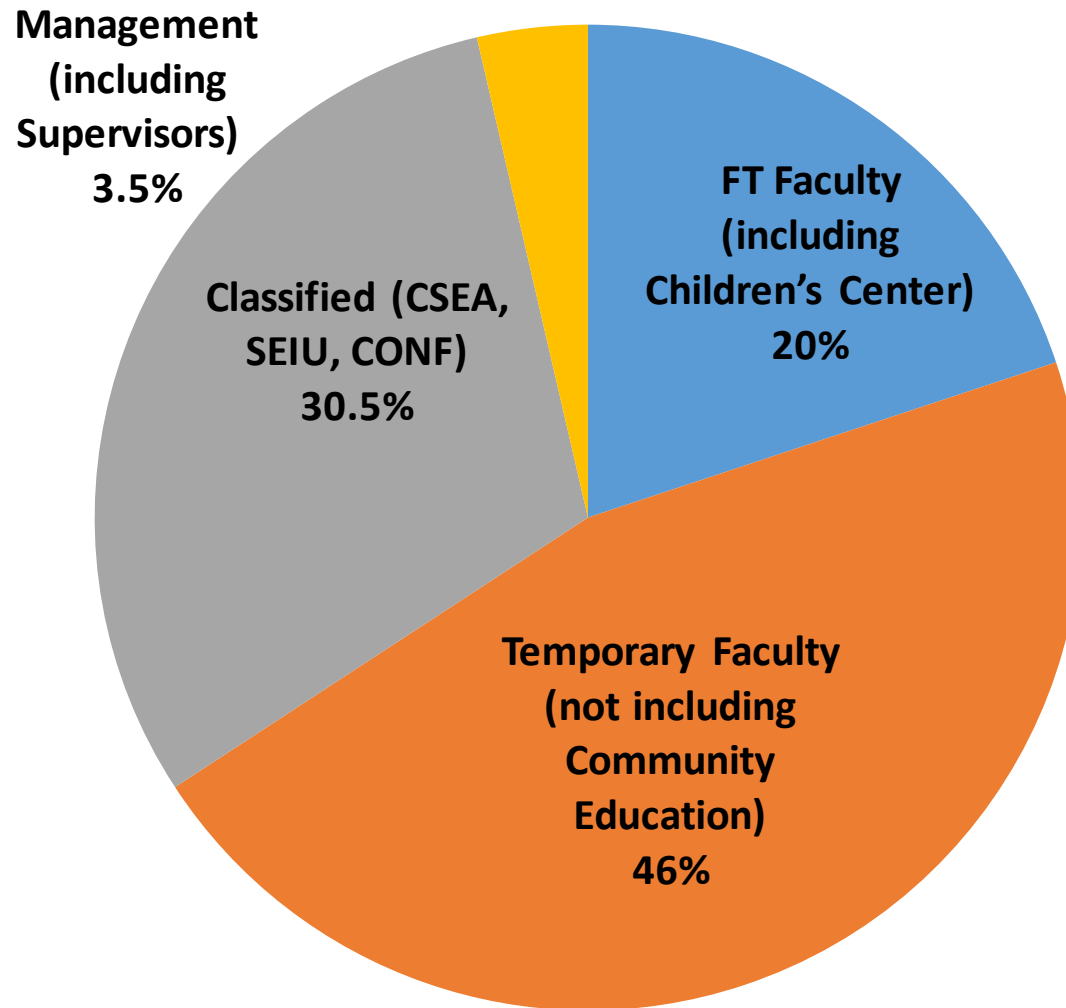

- Comprehensive assessment of all facilities at both campuses in 2014
- Still have buildings over 40 years old
- One building is 80 years old
- Facilities role in enabling COM to effectively prepare students

2014 Facilities Assessment Results

- Identified \$265 million in need
- Board of Trustees considering new facilities bond election
- June 2016 ballot

- Ensure current and future student access to 21st century teaching and learning space
- Support current and future curricular and program offerings
- Accommodate enrollment growth
- Facilities compliant with all fire, life, safety codes, and standards
- Meet District sustainability standards

- Maintain District facilities in a manner that maximizes operational efficiencies and longevity of spaces that support student learning and success
