

## Marin Community College District COVID-19 Student Safety Agreement

COVID-19 (novel coronavirus) is present in our region and is being transmitted via community and person-to-person contact. The Marin Community College District is taking precautionary measures in accordance with public health officials in an effort to protect the health and safety of our students and employees. This agreement is an acknowledgement that you will adhere to the following safety measures. This must be completed before you can come to campus for your course requirements. You will complete this form for each course in which you are enrolled with in-person instruction.

**The course you have enrolled in will have limited in-person instructional days. Each day you are scheduled to have in-person instruction, complete the self-screening health assessment online survey that your instructor will provide the link to you via your MyCOM email and/or on the course Canvas page. You may also access this survey by scanning a QR code posted at the classroom.**

You may report to class if the results of the survey symptom tracker displays a green check mark.

Prevalent symptoms of COVID-19 where you should seek medical advice include:

1. Fever or signs of a fever (fever of 100.4 or chills).
2. Respiratory symptoms such as cough, sore throat, or runny nose (other than seasonal allergies or asthma).
3. Have had close contact with a suspected or known COVID-19 patient (spent longer than 15 minutes within 6 feet of someone who was sick with a fever and cough).

If you have had close contact with a suspected or known COVID-19 patient (see number 3) then notify your instructor and stay home and self-isolate for 14 days and notify any close contacts to do the same. You will not be penalized for staying home if you are ill or self-isolating due to possible exposure.

If you have a fever or any signs or symptoms of respiratory illness (number 1 and 2) then notify your instructor and stay home and self-isolate for 14 days. Contact your health provider and notify your close contacts to quarantine for 14 days. If public health officials update isolation guidelines, you will be expected to comply with the updated guidelines (<https://coronavirus.marinhhs.org/>).

Additionally, you must adhere to the following requirements:

- You will wear a facial covering at all times while on campus. If you have a medical condition or disability that precludes you from wearing a facial covering, you must obtain an accommodation for an alternate option by contacting Student Accessibility Services **prior** to your first scheduled day of in-person instruction: [sas@marin.edu](mailto:sas@marin.edu) or call (415) 485-9406.

- You will wash your hands with soap and water before you start class and throughout your time on campus.
- You will practice physical distancing, which includes sitting and/or standing at least 6 ft. from other people, will not have any physical contact with other individuals, and will not share food, drinks, or other items that could unnecessarily expose you or another person to COVID-19.
- If you start to feel feverish or have respiratory symptoms while at school, you will notify your instructor and go home immediately.

I, \_\_\_\_\_, hereby agree to the above safety requirements and understand that any violation of the above requirements or attending class without clearance from the symptom tracker (green check mark) is a violation of Board Policy 5500 “Standards of Student Conduct” and could result in disciplinary action per Administrative Procedure 5520 “Student Discipline and Due Process.” Should I test positive for COVID-19, I authorize the District to share my name, contact information, and reported positive COVID-19 test results with Marin Health and Human Services.
